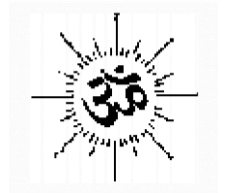

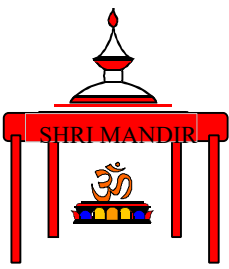

- All exhibitors are responsible for having appropriate business license and non-profit certificates where applicable.
- Restaurants must obtain required health permit and satisfy other special requirements, if any.**
- Diwali Mela Committee** reserves the right to refuse or limit the number of booths for any one type of business / organization to maintain diversity. Exhibitor space will be assigned and / or modified as necessary for the benefit of all the participants.
