Read the following details before filling out the nomination form:

- 1. Requirements as per constitution:
 - a. The candidate has to be a life member to be eligible to become a member of the Executive Committee. In the absence of action by the membership to fill all Executive Committee positions, the Board of Trustees may appoint members to the Executive Committee.
 - b. The EC term is 2 years. One can be a member of the Executive Committee for 3 consecutive terms only. You can be a non-voting member of Executive Committee with no term limitations.
 - c. Only one member of a family is eligible to be an office bearer on the Executive Committee. Family members of an Executive Committee member are encouraged to become a non-voting member of the Executive Committee.
 - d. Trustees shall not serve simultaneously as members of the Executive Committee.
 - e. While a Trustee's spouse cannot serve simultaneously in the Executive Committee, he or she is encouraged to become a non-voting member of the Executive Committee.
- 2. Information on Executive Committee President and Officers:
 - a. The Board of Trustees and the outgoing EC officers shall appoint the new EC President.
 - b. EC officers (Vice President, Secretary, Communications Coordinator, Treasurer, Joint Treasurer, Operation and Scheduling Coordinator) shall be elected by the newly elected EC members among themselves at the first EC meeting after general body meeting.
 - c. You can declare your intent for any EC officer position at the first meeting of the EC.
 - d. If you are interested in knowing the role and responsibilities for any of the officer position, please contact any member of the Nomination Committee.
- 3. There are other requirements such as minimum attendance and other items. See the constitution and bylaws on Shri Mandir website, in the service tab, under the bylaws folder." https://shrimandirsandiego.org/Shrimandir/bylaws"
- 4. The constitution allows for absentee voting which we plan to conduct in case there are more nominations than seats available. Your name, e-mail, and phone # will be displayed on the absentee ballot unless you choose not to publish your information on the previous page.
