Read the following details before filling out the nomination form -

According to Shri Mandir's constitution and bylaws approved in May 2016:

1. The candidate has to be a life member for the past three years to be eligible to become a member of the Board of Trustees.
2. There are 3 (three) BOT seat open for election. All three are for six years term. Based on the constitution and number of members in different categories of membership, one BOT seat shall be elected from Grand Patron Life Member category and 2 BOT seats shall be elected from the Life Member category. If there is no application from Grand Patron Life Member category, all three seats will be elected from the Life Member category. For details, please refer to the constitution and bylaws or contact one of the nomination committee members.
3. Other Considerations:
 - a. A trustee shall be actively participating at Shri Mandir
 - b. Only one member of a family is eligible to be on the Board of Trustees
 - c. Trustees shall not serve simultaneously as members of the Executive Committee
 - d. While a Trustee's spouse cannot serve simultaneously in the Executive Committee, he or she is encouraged to become a non-voting member of the Executive Committee. There are other requirements such as minimum attendance and other items. 4. If there are more nominations than the open seats election will be conducted using ballots. Shri Mandir constitution allows for absentee voting which will be published as well.
